Conversion of side barn to domestic accommodation 4. Reconfiguration of internal modern partition walls and associated internal alterations 5. Replacement of septic tank with package sewage treatment plant discharging to a flowing watercourse 6. Improvements to highway access. Councillors viewed the plans and decided that it would be necessary to do a site visit. Clerk to get in touch with the Owner to get permission for a site visit Friday afternoon at 3.30 pm .

7/2022/5678 – Field Head Farm, Outgate, Ambleside, LA22 0PY – Amendment to design of porch, condition 2 (plans) on planning permission 7/2022/5112 two storey extension, single storey porch, external and internal alterations. Councillors viewed the plans and had no objections. Clerk to report to Planning.

179/2022 Hawkshead Project

Through Cllr Brereton, Cumbria County Council have given a grant of £5000. The Chair and Clerk had had a meeting with SLDC regarding LIPS funding, they provided an update on funding and the current situation. A meeting is scheduled for mid-December by which time they need a start date for a contractor.

R G Parkins have been in touch with some questions before the tenders are re-issued:- whether the tarmac has been tested for contamination and the disposable of this needing to be in the costs. Whether the use of the Old Police Car park will be confirmed for the whole of work time. Whether access to the roads near the work will need access.

Discussion took place and it was agreed that the Clerk should ask RG Parkins how we go about getting the tarmac tested as a matter of urgency. Regarding the car park it was agreed that the Clerk should approach the National Trust and ask if they are able to help with an alternative or would consider allowing contractors to use the old show ground field. Access to the area at all times will need to be considered.

Cllrs ask for photos to be sent when he sends his invoices please. Lengthsman to be asked to keep the drains up Vicarage Lane clear when in the village and the saplings at the bottom Roger Ground need trimming back.

Old Police Car Park permit application forms – the Post Office have kindly handed the applications out from their counter for a number of years for which the Parish Council is very grateful but as they are sadly finishing at the end of December consideration of how the permit application forms are going to be distributed/collected needs thought. Discussion took place and it was agreed that it would be great if a local business would continue this and Simon Butterworth was suggested. The Chair will ask him before the next meeting.

Member of the public had approached a Councillor - concern regarding a problem of people driving up the one way street the wrong way at speed around 9 am can be a busy time for this but happens a lot during the day. Clerk to write to the Chief Constable and inform them of the ongoing problem and that is by the Primary School and Preschool please could something be done about this. Also write to Highways highlighting concerns.

Member of the public – had asked the Parish Council to look into an agreement which had been discussed a long time ago where the PC would make sure that Park House is continued to be used for the purpose of Girlguiding. Current Councillors were unaware of this but will ask past Councillors and Cllr Johnston will get in touch with the member of the public and find out the background and what is required.
