41/2021 Police

42/2021 District Councillor

Cllr Coward reported that there are still SLDC Covid grants available especially the Discretionary grant they believe there are businesses that have not taken this up and are encouraged to. Consultation is ongoing regarding the return of visitors to the Lakes and making sure visitors respect the area we are living in. They will be promoting the Countryside Code.

Consultation regarding the Local Government restructure, parishes are encouraged to comment on this, 4 options for the new structure.

Greening of South Lakeland – parishes are encouraged to have as a standing item on their Agenda. All about protecting climate change and green issues. To encourage local community to get involved in making their local environment greener. Four phases first phase costs £50 SLDC paying half of this so PCs pay £25.

43/2021 County Councillor

Cllr Brereton reported that highways officers issues were ongoing but some issues had slowed down due to uncertainty regarding elections. Now the elections are postponed things can be moved on, money can be

allocated it would be useful for local parishes have similar local issues put all any Traffic Regulation Orders together at the sametime it will save on costs re advertising etc.

B4RN – there is good interest and potential volunteers but has not received a recent update on the situation.

Cllr Brereton will be reporting back that there was a lack of communication regarding the emergency roadworks at Clappersgate and the road closure. Poor signing, notifications on the road were too late, this has been flagged up with Coniston PC, the published diversion was taking traffic down to Newby Bridge.

Windermere Ferry Advisory Group meeting - they are making a business case, sourcing expert consultancy before procurement. Cllr Brereton has asked for a public meeting but not heard back yet but will be chasing this up to see if this is something that can be done. No big decisions will be made before September.

Cllr Spedding asked for help with the Squares Project at the North End of the village – Cllr Brereton has spoken to Victoria and Helen about funding. Agreed its importance and will help get this project moving.

He talked about landowners being encouraged to create temporary car parks/campsites for 56 days this year, to stop fly camping and inappropriate car parking.

A Councillor asked if there were any landowners planning to do this in the area. Cllr Brereton did not have this information as this is being done through LDNPA. Question was asked if he was aware of anyone in the local area applying for it. Cllr Brereton is not aware of anyone in this area.

44/2021 Public Participation

A Member of the Public wanted to discuss item 9.2 on the Agenda 7/2021/5123 – Land to rear of High Cross, Hawkshead, Ambleside, LA22 0QB – Use as 2 dwellings. He introduced himself as a Local Town Planning Consultant and has been asked to representative the neighbours and local occupants at this address. He wanted to clarify for the Parish Council that although the correspondence from the Planning Department, Lake District National Park Authority (LDNPA) says for information only, the Parish Council can comment on this and he has been in touch with LDNPA to confirm that in future their correspondence for this kind of issue will clarify this.

The planning is for a Certificate of Lawfulness for the 2 dwellings. They are claiming that the properties have been lived in continuously for 10 years, it was felt that this was not the case. His clients are saying that they believe that the dwellings have not been continuously occupied for 10 years, if the PC have any information or believe the applicant is wrong any information would be very gratefully received. Council tax and electricity have come through High Cross. The owner of the dwellings lives in Ribchester not on the electoral roll and everyone currently living there is on other electoral roles. It is a factual matter to be considered, have they been living there continuously for 10 years, this will be very important information. LDNPA give an 8 week period to determine the application and have to decide whether its lawful or not, they have asked for response by end of March. They ask the Parish Council to consider this and write to LDNPA to confirm whether they consider that the properties have had full residency. Councillors decided to discuss this further under the Planning section.

Members of the Public who purchased Fell Foot in November as a holiday let – wanted to add that they were concerned that there wasn't any information on properties behind theirs, they were not aware that they were there or that anyone was living there. All the Deeds were signed with no indication that the property had any neighbouring planning applications etc.

Member of the Public also present regarding the above planning and particularly interested in the certificate of lawfulness and the implications of this would be? Would the sheds be there forever or would they be able to build on the site? It was confirmed that the implication would be that they would be able to build on the site and there would not be the option of a local occupancy clause placed on the property.
