Member of public – after the heavy snowfall they had come to offer their disgust and anger at the treatment of the north end of the village, why was only the south end cleared. There were people who could not get to the Coop or out of their homes. Cllrs were unsure who had cleared the south end but felt it was done by private individuals. The PC has no grit as the County Council will provide any or allow the PC to use the snowplough/gritter on the highway. They want the contractor to do training but are not able to identify which course they want them to go on. If the PC were allowed to use the snowplough and gritter the highways around Hawkshead would have been cleared as it has been previously. Clerk to email Cllr Pender to express disappointment in the way Hawkshead was not helped and point out a salter, plough and funding to do the job are all in place but the previous council obstacles have caused issues highlighted by the events that happened on the 3rd we feel our hands are tied.

Member of the public wanted to make Cllrs aware that they had received a letter from Planning Authority regarding a shepherds hut which has been on their property for 2 years informing them that they have received a complaint that it does not have planning permission and this is being investigated. They feel the hut is an asset to the village as it offers a different type of accommodation for visitors and has been busy bringing people to Hawkshead.

Member of the public wanted to know if there had been any further updates on the Windermere Ferry service. Cllrs had received a report from the PC representative (the feedback from the Council was read out). They are concerned that service is currently very limited and is having an effect on the economy in Far/Near Sawrey and Hawkshead. Clerk to email Cllr Pender to ask if she can find out what the future plans are regarding the limited service being offered, how the Council plans to solve the problems being encountered with ferry maintenance issues and what sort of service they are going to provide.
