A member of the public – voiced concern regarding how untidy the village has become, the Coop are leaving rubbish outside such as boxes of chicken, bread buns in clear white bags on the street, cages and shelves are also just being left in the ginnel this never used to happen. Clerk to contact the Coop asking them to keep the village outside the store clear of shelves, crates, cages ask them to tidy up under the archway and food stuff should not be left outside attracting vermin. They also mentioned that the rose bush outside the Ice Cream shop is growing out into the road. Clerk to ask Ice Cream shop to tie or trim back the rose so it is not causing an obstruction.

Concern was raised regarding staff in the pubs and the lack of a police presence after a recent incident. The PCSO used to pop into the village and spend time talking to local businesses with any concerns, crime seems to be on the increase and a more regular police presence may help the situation. Clerk to contact the local PCSO and see if a more frequent police presence is possible.

Phonelines are down in the Field Head area concern had been raised that residents in the area have been without a phone line for over 3 weeks and some of the residents are vulnerable and rely on carelines which do not work without a phoneline. The line had been accidentally been dug up Openreach have been told that they can't go into the field to lay a cable. Clerk to write to Tim Farron MP to see if he can help. Also try and contact Openreach. Clerk to also send a note to local Doctors seeing if they can help put any pressure on especially with vulnerable patients.
