National Trust – the Chair read an update from Laura Ruxton as follows:-

**Estate Information -** New tenant in Castle Barn Cottage, Hawkshead Field Cottage will be on the market in a few weeks post decoration. There will be no voids once these are let.

**Transport** - the bus trial is going well despite generally lower visitor numbers this summer. The numbers have come up to over 50 people per day using the bus from the lake shore.

**Hawkshead Visitor Activity -** Wilder Lakes exhibition that will be in the old Gallery property in August and September. Beatrix Potter Trail is with the designer this week and will be signed off for print. Once printed we would like to distribute these with businesses and will work through the Destination Hawkshead Group to do this. In addition we would like to put some fixed signs of relevant places in the village to make the trail interactive – we will approach the chair of the Parish Council with a list of requested locations.

Member of the public reported that the old police car park has recently had 2 or 3 cars without the correct permits, making it difficult for permit holders to find a space. Clerk to write to all the holiday companies who have properties in the village to ask them to inform their guests that if they park in the OPCP they will get a ticket.
