# 70/2024 Police

The Clerk had looked on the Police.uk website on 19/5/24 the statistics showed were from March 2024 - 1 criminal damage/arson Nr Kings Yard – investigation complete no suspect identified; 1 drugs on or near Scarhouse Lane – further investigation not in the public interest.

# 72/2024 Public Participation

The attendance of 30 members of the public was mainly due to planning application 7/2024/5178 – Land at Bragg Field, Bragg Field, Hawkshead, LA22 0QW listed in planning below. The Chair asked for a show of hands for who was against and who was for the application three quarters of those present were against the application. The Chair gave each individual an opportunity should they wish to put their points of view across, below is a summary of these points:-

Against:

- Properties within the planned site area do not want a petrol station on their front door health and pollution concerns including smell, sound and light.
- Concern about the noise from the fans from the Spar
- Concern regarding the bins which are to be placed against the resident property boundaries
- Fuel station is not necessary, the village has coped for 20 years without one something to increase trade would be more appropriate
- Concern people would stop use the shop and not go into the village
- Home owners in the area felt it would de-value their homes
- Concern about the drilling to test the ground was shaking their properties what impact would this build have on their property foundations.
- Road infrastructure will not cope with additional delivery lorries and tankers
- The village Coop will suffer along with other businesses
- Concern regarding parking spaces for the doctors surgery and easy access for patients
- Upset that local residents who live next to proposed site have received no consultation/notifications of these plans
- Parking issues for houses on the site

- It was felt that there is a need for a commercial property to enhance the village but not necessarily a petrol station the loss of the Post Office and the Beatrix Potter Gallery has had a big impact on the village.
- Staffing issues already a problem in the village where are the extra staff going to come from? For:-
- Concern that the village needs invigorating and with visitor numbers decreasing this may help
- It was felt a garage would encourage people to drive through to Hawkshead and stop and look round.

The Chair thanked the public for the input and Councillors agreed to do a site visit tomorrow (Wednesday) at 11 am and report their decision to the Clerk to forward on to the Planning Department, LDNPA.

The Chair from Hawkshead Show – had an issue with a road that was closed at last years event causing a lot of issues for participants. Action Clerk to contact Highways and Electricity North West to notify of the date Tuesday 20<sup>th</sup> August and ask if they could make sure there are no road closures on access roads to Hawkshead on that day.

Member of the public reported that all the drains are blocked – Clerk to continue to report them.

Laura Ruxton, National Trust new General Manager, attended the meeting was welcomed by the Chair, she gave a quick background introduction about herself and then gave an update: she confirmed that the National Trust are obliged to bring the Beatrix Potter artwork back to the Lake District but the gallery is not suitable due to humidity issues. They are currently digitalising the images. There is an art exhibition planned in the gallery August/September this year with local artists there will be digitalised copies of the Beatrix Potter images on display. There is work to be completed on the roof of the property. In mid July they will be launching a Beatrix Potter trail they have been working with a design company and children at Hawkshead Primary School.

The NT are helping to sponsor a bus service which will run until first week in November at the moment the service is not breaking even (not helped by the Ferry being closed) Mountain Goat are really hoping the numbers will pick up. Housing Castle Farm cottage viewing last week, Hawkshead Field Cottage out on the market in June will then have no vacant properties. They are looking at putting the old ticket office back to accommodation within the residential house. Laura also reported that long term visitor numbers dropped considerably in the local tourist attractions from figures 2018.

Members of the public voiced concern that the NT focus is on Wray Castle and are concerned that the Beatrix Potter gallery is a huge loss to the village, they felt that the paintings and properties were left to the trust to be kept in the local community and this is not happening.

Member of the public - Brathay marathon why was it on a Saturday? It was reported that Brathay was trying to generate more numbers to attract people to stay in the local area rather than come for the day. Although it was signed in advance some had not realised the day change however the later start time gave time for people to get out of the village, reports that there was someone on a quadbike who was speeding.through outgate thought to be part of the event – Cllr Johnston will find out who is responsible.

Member of public - grass in Old Police Car Park has not been cut - it was reported that it had been cut in the last couple of days, broken fence and boundary fence – broken fence is being worked on by the Lengthsman, Cllr Spedding with contact the previous chair to ask what had happened regarding the boundaries.

Member of the public – the footpath from Roger Ground to Hawkshead is overgrown with brambles etc Clerk to contact Sara Spicer, LDNPA

Fieldhead road end where the off road footpath there is fencing that is broken and on the footpath - Cllr Johnston will find out who is responsible for this it is on Attwood land.

#### 77/2024 Hawkshead Destination Project

The clerk attended a Teams meeting on Monday and was able to provide a brief update:-Communication channels have been opened with Electricity North West (ENW) this will hopefully stop a situation happening like the recent road closure as well as the ferry out of service. Village visitor numbers there is no pattern to numbers but it was felt that in general they are down, hoping for a busy half term to start the season. Discussion regarding a number of events in the area in one weekend, it was felt that this results in lower visitor numbers.

Transport was discussed, good news that the ferry is back on, the foot ferry had completed 2,000 trips and bus had taken public from Ferry Nab. Staff from the ferry, bus service etc were invited to a visit to Hawkshead to see what is on offer to help market the village. Social media has "I love Hawkshead" facebook and Instagram sites and the number of followers continues to grow.

Car parking looking at 30 min disc parking in Hawkshead like they have in Ambleside. Social housing was discussed, with 2 possible sites which need to be assessed by LDNPA, Cllr Pender has asked for a PC Cllr to be a representative on the committee.
